SECTION 4: First aid measures

4.1. Description of first aid measures

If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet.

Inhalation

Terminate the exposure immediately; move the affected person to fresh air. Take care of your own safety, do not let the affected person walk! Beware of the contaminated clothes.
